# **ORDER:**

- 2. In the Government letter fifth read above, the Director of Medical Education was requested to conduct an inspection on the premises of the Trust for considering the request above. Accordingly, the Director of Medical Education has constituted an inspection team to verify as to whether the proposed Pharmacy College has fulfilled the conditions prescribed by the Pharmacy Council of India, New Delhi and Government in the Government Order first to third read above.
- 3. In her letter sixth read above, the Director of Medical Education has submitted the proposal stating that the said institution has fulfilled the norms

prescribed by the Government and recommended to grant permission to Chairman, Trustee, Karpaga Vinayaga Educational Trust, Pudukottai District to start 100 seats in B.Pharm course at Karpaga Vinayaga Institute for Pharmaceutical Sciences, Chengalpattu District.

- 4. The Government have examined the case in detail in the light of the Inspection Report and the recommendation of the Director of Medical Education and decided to accept the same. Accordingly, the Government hereby grant permission to the Trustee, Karpaga Vinayaga Educational Trust, Pudukkottai to start four years course in Bachelor in Pharmacy (B.Pharm) course with an annual intake of 100 (hundred) seats at Karpaga Vinayaga Institute for Pharmaceutical Sciences, Chengalpattu in S.F.Nos.114/2, 114/3, 115, in Vaiyavoor Panchayat, Moosivakam Village, Maduranthagam Taluk and Panchayat Union, Chengalpattu District from the academic year 2023-2024, subject to condition that it fulfills the general conditions laid down in G.O.(Ms)No.148, Health and Family Welfare (PME) Department, dated: 24.4.2018 as applicable to this proposal before admitting the students.
