#### PREAMBLE

In the reference 1<sup>st</sup> cited, the Government in G.O.(Ms) No. 147, dated: 05.05.2023 of Health and Family Welfare (PME-2) Department, has permitted Karpaga Vinayaga Educational Trust, Pudukkottai, to start B.Pharm. Degree Course with an annual intake of 100 seats in the name and style of **"Karpaga Vinayaga Institute for Pharmaceutical Sciences, Chengalpattu"** in S.F. Nos. 114/2, 114/3, 115 in Vaiyavoor Panchayat, Moosivakam Village, Maduranthagam Taluk and Panchayat Union, Chengalpattu District, from the academic year 2023-2024.

2. In the reference 2<sup>nd</sup> cited, the Managing Trustee, Karpaga Vinayaga Educational Trust, Pudukkottai, has requested the University to issue Letter of Consent of Affiliation to start B.Pharm. Degree Course at "Karpaga Vinayaga Institute for Pharmaceutical Sciences, Chengalpattu" in S.F. Nos. 114/2, 114/3, 115 in Vaiyavoor Panchayat, Moosivakam Village, Maduranthagam Taluk and Panchayat Union, Chengalpattu District.

3. In the reference 3<sup>rd</sup> cited, an inspection was conducted on 24.05.2023 by the Inspection Commission constituted for the said purpose and the commission has submitted its report. Scrutiny of the inspection report, no specific adverse remarks or objection was found. Consequently, Letter of Consent of Affiliation was granted as in the ref. 4th cited.

4. In the reference 5<sup>th</sup> cited, the Trustee, Karpaga Vinayaga Educational Trust, Pudukkottai, has requested to issue Provisional Affiliation order to start B.Pharmacy Degree course along with the approval of the Pharmacy Council of India (PCI), New Delhi.

5. In the reference 6<sup>th</sup> cited, the Pharmacy Council of India(PCI), New Delhi has granted approval to "Karpaga Vinayaga Institute for Pharmaceutical Sciences, Chengalpattu" for 2023-2024 academic session for conduct of 1st year for 60 admissions for B.Pharm. course

6. An inspection was conducted on 18.08.2023 for the issue of Provisional Affiliation and the Inspection Commission constituted has submitted its report. Scrutiny of the inspection report, no specific adverse remarks or objection was found.

#### **ORDER:**

Consequent to the issue of the Consent of Affiliation, approval of Pharmacy Council of India, New Delhi and the University Inspection reports, the University grants the Order of Provisional Affiliation to Karpaga Vinayaga Educational Trust, Pudukkottai to start B.Pharm. Degree Course with an annual intake of 60 seats in the name and style of "Karpaga Vinayaga Institute for Pharmaceutical Sciences, Chengalpattu" in S.F. Nos. 114/2, 114/3, 115 in Vaiyavoor Panchayat, Moosivakam Village, Maduranthagam Taluk and Panchayat Union, Chengalpattu District from the academic year 2023 - 2024.

a. This order is granted subject to usual terms and conditions which are as follows:-

- The admission procedure as laid down in Govt. order, Health and Family Welfare 1. (MCA1) Department should be followed strictly. The seats available in B.Pharm. Degree Course shall be filled up as per orders in force. The Management shall follow a transparent and reasonable method of admission for the Management quota as per orders in force.
- The candidates should have been admitted before the cut off date. 2.
- The Trust should agree for the Inspection of the College by the Tamil Nadu Dr. M.G.R. 3. Medical University at any time according to the Statutes, Ordinances, Regulations and Rules for Pharmacy College framed from time to time.
- The Candidates admitted will take up their 1st B.Pharm. Degree Examination as per the 4. existing regulations of this University.
- The Trust and the Pharmacy College should abide by the Statutes, Ordinances, 5. regulations and Rules framed by the Tamil Nadu Dr. M.G.R. Medical University on matters of syllabus, Examinations, Code of conduct, extracurricular activities, etc.

6. The conditions that may be prescribed by the Pharmacy Council of India, New Delhi shall be fulfilled and the rules and regulations of the central council shall be followed strictly.

- 7. Only qualified staff shall be appointed to handle the classes in the B.Pharm. Degree course.
- 8. No Unqualified staff shall be appointed.
- 9. Only eligible candidates according to the regulations of this University shall be admitted to the I B.Pharm. Degree Course. While making admissions, the Rule of Reservation of the Government of Tamil Nadu shall be adopted strictly.
- 10. The sanctioned strength for said Degree Course should not be exceeded.
- 11. There shall not be any financial Commitment either to the University or to the Government.
- 12. Hostel accommodation shall be made available for the students both Male and Female separately.
- 13. The admission of students should be made after the date of issue of this proceeding.
- 14. Required furniture shall be provided wherever they are necessary.
- 15. Furnishing of false information to the University on any approval matter or suppression of facts while furnishing information to the University or Violation of any of the Statutes, Ordinances, Regulations, Rules, instructions or conditions of affiliation shall result in withdrawal of the Affiliation of the College.
- 16. The Institution shall show evidence of an annual income of not less than Rs. 4,00,000/-(Rupees Four lakhs only) excluding the interest accrued from the Security Deposit mentioned in the statutes to facilitate the proper running of the proposed Pharmacy College.
- 17. The College shall furnish a "Utilisation Certificate" to the University stating that the interest accrued on the Security Deposit has been utilised towards maintenance of the Pharmacy College.
- 18. The Trust shall have a duly constituted Governing Body with a representative of the teaching staff to advise the Principal in the affairs of the College. A record of proceedings of the said Governing Body of the College shall be maintained by the Principal.

- 19. The Governing Body of the College shall meet at least once in every three months to consider the Budget Estimates and such meet in May June each year to consider the Annual Report, the audited statement of accounts, changes in the pattern of staff, subjects or courses in which fresh affiliation or approval is to be sought in the following year, etc. A Copy of approval notice of the meeting shall be sent to the Registrar, atleast 15 days before the date of the meeting. A copy of the minutes of the meeting shall also be sent to the Registrar of this University within 15 days from the date of the meeting.
- 20. The College shall furnish a Budget for each year of study and a separate development budget which will cover the expenses for the fulfillment of the requirements prescribed in the first and second year of the course of study.
- 21. The Provisional Affiliation now granted by the University is for the first year of B.Pharm. Degree Course only.
- 22. After fulfilling all the conditions required to be fulfilled by the college under the Tamil Nadu Dr. M.G.R. Medical University by the time only six months period is left for the first year B.Pharm. Degree Course of study, the Institution shall apply to this University for the grant of Continuance of Provisional Affiliation for the second year B.Pharm. Degree Course of study.
- 23. The minimum system configuration required at the institution for using the University CMS 2.0 software application and for the University Examination SEQUEL are :
